
Scientific Fixed Fishing Net Survey Operations

Please be advised that Centre for Marine and Coastal Studies Ltd (CMACS) will be undertaking a tangle net survey for scientific survey purposes south and south west of Gwynt y Môr Offshore Wind Farm in May 2016.

A map of the survey areas and positional coordinates corresponding to the limits of these areas are provided below. Survey operations are planned to take place **between 16 and 31**May. There will be **approximately four days** at sea, weather dependent. Survey days may not necessarily be consecutive.

Vessel and Operational Details

Quest LK500

Quest LK500 is a 10 meter mono-hull fishing vessel with a white cabin and red hull. The vessel will operate on a daily basis from Conwy, North Wales.



Survey operations will involve deploying four sets of 1000 yard tangle nets on two separate occasions. A wide berth is requested at all times as the vessel will be restricted in her ability to manoeuvre. The skipper will monitor channel 16 throughout survey days.

Soak time for each deployment will be 24 hours. Nets will stand from approximately 18 to 24 inches off the seabed when the tide is slack and lay flat on the seabed when the tide is running. Both ends of the nets will be marked with an orange buoy and Dahn Pole Flag, which will be marked with vessel number and contact details, in addition to flashing lights.
