
Notice to Mariners

INSTALLATION OPERATIONS

Please be advised that Minesto UK Ltd will be carrying out installation operations of their Deep Green DG500 tidal energy converter in the company's Agreement for Lease (AfL) area in the Holyhead Deep.

The Project is located approximately 6 km West of South Stack, off the coast of Anglesey, North West Wales, in the southern section of the AfL area, as part of the Holyhead Deep.

Overview of the Area



Schedule

The installation is due to begin on the 5th August 2019, weather dependant,

Installation operation

Will consist of the following operations;

- Mooring of a Micro Grid System (MGS) Buoy, MGS 1, Special Purpose Light Buoy, FI(4)Y.15s to the Pre-laid anchor spread.
- Laying of the Power Transfer Fastening (PTF) Assembly (Umbilical) along the sea floor.
- Connecting the Kite System (consisting of the Kite, Tether, Bottom Joint Connector) to the pre-laid Gravity Base Structure (GBS) Foundation.

The expected duration is 7 days.

Safety Zone

A safety Zone of 500m, on the sea surface, will be established on the MGS Buoy (53° 17' 47.739" N 004° 47' 45. 493" W) and all vessels are asked to give a wide berth to the MGS Buoy and any vessels working on site.

Island Vanguard is an 86m Offshore Supply Vessel with a Blue hull and White superstructure. The vessel will operate on a 24-hour basis and will display appropriate day shapes & lights during installation operations. The vessel will actively transmit an AIS signal.
