#### 1. Introduction

The Awel y Môr Offshore Wind Farm is an extension of the Gwynt y Môr Offshore Wind Farm originally developed by RWE in the Irish Sea. The proposed site has a total area of 106km2 with a capacity of approximately 576 MW. The development will include offshore transmission assets, with the export cable route likely to reach landfall on the North Wales coast to allow a grid connection at Bodelwyddan in Denbighshire.

Fugro will undertake a geotechnical site investigation to characterise the Awel y Môr Offshore Wind Farm extension areas.






Figure 1: Project Location Map




Figure 2: Proposed Borehole Locations



# 3. Geotechnical Site Investigation

The geotechnical investigation is expected to be carried out from the geotechnical DP2 drilling vessel Gargano starting around 1<sup>st</sup> August. Please note that the mobilization and demobilization dates will be dependent on the prevailing weather conditions and work progress. The vessel will be deployed for a period of between 3 to 5 weeks.

Operations will be conducted on a 24-hour basis. The vessel will be having regular port calls for crew change and bunkering purposes. Typically, a 4-week rotation schedule is maintained.

As the Gargano will be conducting drilling operations using a dynamic positioning system, it is requested that all vessels operating within this area keep their distance, maintaining at least the 500 m exclusion zone, and pass at minimum speed to reduce vessel wash.
