

NOTICE TO MARINERS

Please be advised of this notice advising mariners of the geophysical survey and ROV diving along the Interconnector pipelines 1 and 2 (IC1 and IC2), as well as at the Isle of man 'Tee' in UK and Irish Waters. The '4Winds' will be conducting the geophysical surveys along the entire length of the pipelines and ROV diving operations on locations along the pipelines and at the Isle of Man 'Tee' whilst on DP2.

The work will commence earliest on the 4th of December and is scheduled to until the end of December, subject to weather and additional scopes.

Operations

The 4Winds will work on a **24-hour basis**. During the survey and ROV diving operations vessel will be displaying the relevant IRPCS day shapes and night lights and will be monitoring VHF Channels 16 and 12 and have a pro-active attitude monitoring the surroundings.

Due to ROV operations being operated from the vessel we kindly ask that all vessels in the local vicinity observe a **500m stand-off** at all times.

During geophysical survey operations we kindly ask that all vessels in the local vicinity observe a **250m stand-off** at all times.
