Activities

All mariners are advised that MPI Adventure will be carrying out maintenance operations at Rhyl flats Offshore Wind Farm from 10/04/2026 until 18/04/2026. These dates are subject to weather and sea conditions. Specific coordinates of locations where works occur are found below.

Requirements of Mariners

“Mariners must observe the safety zone of 500m when the MPI Adventure is attached or anchored next to RF14, RF18, RF07 & RF19. It is also requested that mariners observe a distance of at least 500m when MPI Adventure is manoeuvring into position for the safety of all sea users operating within the wind farm, and to ensure MPI Adventure can safely position itself without negative interactions with sea users or their equipment.
